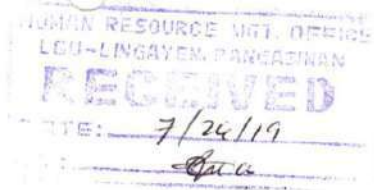
### RESOLUTION NO. 18, S-2019

#### CONFIRMING THE APPOINTMENT OF MRS. MAE V. RUEDA AS MUNICIPAL INFORMATION OFFICER OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, Mrs. Mae V. Rueda was appointed by the Municipal Mayor to be the Municipal Information Officer of this municipality pursuant to R.A. 7160, otherwise known as the New Local Government Code of 1991;

WHEREAS, there is a need to fill up the position of the Municipal Information Officer in order that said office can continuously provide technical assistance and support to the Municipal Mayor and to the municipality in disseminating information particularly those programs and projects which the Municipal Mayor is empowered to implement;

WHEREAS, the Municipal Information Officer shall formulate measures for the consideration of the sanggunian and provide technical assistance and research data required for the delivery of basic services and provision of adequate facilities so that the public becomes aware of said services and may fully avail of the same; develop plans and strategies on programs and projects related to public information and implement them upon approval thereof by the mayor, as the case may be; provide relevant, adequate, and timely information to the LGU and its residents; furnish information and data on LGU's, NGAs, as may be required by law or ordinances, including of those on NGO's, maintain effective liaison with various sectors of the community on matters and issues that affect the livelihood and the quality of life of the inhabitants and encourage support for the programs of the local and national government; be in the frontline in providing information during and in the aftermath of manmade and natural calamities and disasters with special attention to the victims thereof, to help minimize injuries and casualties during and



after the emergency, and to accelerate relief and rehabilitation; recommend to the sanggunian and advise the mayor, as the case may be, on all other matters relative to public information and research data as it relates to the total economic development of the LGU; and exercise such other powers and performs such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, the appointment of the Municipal Information Officer is optional for the municipal government and the term of office is co-terminous with that of her appointing authority as specified in Section 486 (a) of R.A. 7160, otherwise known as the 1991 Local Government Code;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by all members present, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to confirm the appointment of Mrs. Mae V. Rueda, after the extensive interview by the Sangguniang Bayan Members who found her to be more qualified for the Municipal Information Officer position.

RESOLVED FURTHER, that copies of this resolution be furnished the Civil Service Commission Field Office, Lingayen, Pangasinan, the Chief Administrative Officer, Assistant Municipal Treasurer, Municipal Accountant, Municipal Budget Officer and the appointee for their information and files.

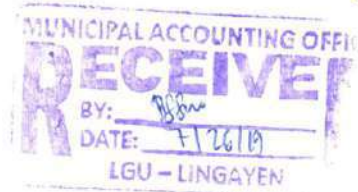
