### RESOLUTION NO. 19, S-2019

#### ENDORISING SBM RANDALL Q. BERNAL AS THE SANGGUNIANG BAYAN REPRESENTATIVE TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB), THIS MUNICIPALITY.

WHEREAS, pursuant to Section 43 (d) (4) of R.A. No. 6975, otherwise known as the "Department of the Interior and Local Government Act of 1990", in consonance with Memorandum Circular No. 91-002 of the National Police Commission (NAPOLCOM), Rule III, Section 1, mandates that there shall be at least one (1) PLEB for every municipality which shall have jurisdiction to hear and decide administrative complaints filed against members of the Philippine National Police (PNP) before the People's Law Enforcement Board (PLEB);

WHEREAS, as mandated by law, any member of the Sangguniang Bayan may be chosen as member of the PLEB for a period of two (2) years effective on the start of the term of office and shall hold office until his successor shall have been chosen and qualified;

WHEREAS, a member to be chosen must have at least a well-rounded experience on legal procedures, police matters and known for his probity and integrity;

WHEREAS, SBM Randall Q. Bernal was chosen unanimously by the Sangguniang Bayan Members as representative of the Sangguniang Bayan to the People's Law Enforcement Board (PLEB) this municipality;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by all members present, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to endorse SBM Randall Q. Bernal as the Sangguniang Bayan Representative to the People's Law Enforcement Board (PLEB), this municipality.
