EXPRESSING PROFOUND SYMPATHY AND SINCEREST CONDOLENCES TO THE BEREAVED FAMILY OF THE LATE SECRETARY TO THE SANGGUNIANG, MR. GENARO L. VALENCERINA, JR. WHO JOINED HIS CREATOR ON MARCH 11, 2020.

WHEREAS, the Sangguniang Bayan and the entire Local Government Unit of Lingayen were shocked, devastated and grief stricken by the news of the unexpected demise of the Secretary to the Sanggunian, Mr. Genaro L. Valencerina, Jr. on March 11, 2020 due to cardiac arrest;

WHEREAS, "Jhun" as he is popularly known was appointed Secretary to the Sanggunian on January 27, 2004, after serving as Assistant Secretary from February 21, 1993 to January 26, 2004;

WHEREAS, as one of the more senior secretaries of Pangasinan, he was elected President of the Philippine League of Secretaries to the Sanggunian, Inc. (PLEASES), Pangasinan Chapter, where he served for seven (7) years from February, 2013 to December, 2019; and was instrumental in steering and empowering the association into a strong, unified and dynamic organization;

WHEREAS, his interest in cooperative management lured him to enter the Lingayen Catholic Credit Cooperative in 2002 where he served in various positions, the last of which is as Board of Director from February, 2019 until his death;

WHEREAS, his rise from the ranks in both government and private service can be attributed to his dedication to work, vast knowledge and experience, and outstanding work ethics which encompasses among others discipline, hard work, and integrity;

WHEREAS, during his long and fruitful government service which spans thirty seven (37) years, he was able to contribute immensely to the development of the Sangguniang Bayan of Lingayen and to the municipality as a whole thereby leaving behind an important legacy to his fellow government servants and his beloved hometown;

WHEREAS, the death of a well-respected employee, inspiring head of office, a man of honor, honesty and humility who dedicated his life to public service is a great loss to the municipality and the people of Lingayen;

WHEREAS, the Municipal Officials and townspeople of Lingayen join his wife and children, relatives and friends in praying for the eternal repose of his soul;
