RESOLUTION NO. 200, S-2020

RESOLUTION AUTHORIZING MUNICIPAL MAYOR LEOPOLDO N. BATAOIL AND MUNICIPAL TREASURER LILIBETH A. MANAOAT TO OPEN A TRUST FUND / SAVINGS ACCOUNT / CHECKING ACCOUNT WITH THE PHILIPPINE VETERANS BANK, LINGAYEN BRANCH, AND TO DEPOSIT, MAINTAIN, AND MAKE WITHDRAWALS THEREFROM.

WHEREAS, on March 11, 2020, the World Health Organization declared the Coronavirus Disease 2019 (COVID-19) as a pandemic due to the rapid increase of cases of infection throughout the entire world;

WHEREAS it was declared in Presidential Proclamation No. 929, Series of 2020 that the entire country is hereby placed in a State of Calamity for a period of six (6) months, unless lifted or extended as circumstances may warrant;

WHEREAS the whole Island of Luzon was placed under Enhanced Community Quarantine since March 17, 2020. As a consequence, the general stoppage of work and suspension of business operations made it difficult for most of our constituents to provide food for the table;

WHEREAS there has been an outpour of monetary donations from generous, civic-minded organizations, corporations, and individuals to help the Local Government Unit of Lingayen provide for the basic needs of its people, especially those most affected by the pandemic;

WHEREAS there is a need to open a separate bank account for these donations received relative to the COVID-19 crisis for proper accounting purposes;

WHEREFORE, on motion of the House, duly seconded, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Mayor Leopoldo N. Bataoil and Municipal Treasurer Lilibeth A. Manaoat to:

(a) Transact business with the Philippine Veterans Bank, Lingayen Branch, and open a trust fund / savings account / current account in the name of the Local Government Unit of Lingayen where the monetary donations relative to the COVID-19 crisis are to be deposited and kept.

(b) To make withdrawals from the said account, including issuance of checks, notes, drafts, as well as any other debit instructions of transfer of funds, provided they shall bear the signatures of the Hon. Mayor Leopoldo N. Bataoil and Municipal Treasurer Lilibeth A. Manaoat.

(c) To sign all forms, documents, and agreements necessary for the above-stated purposes.


RESOLVED FUTHER, that copies of this resolution be furnished to the Office of the Mayor, the Treasurer's Office, and Accounting Office for their information and records.


