### RESOLUTION NO. 213, S-2020

#### REQUESTING HONORABLE GOVERNOR AMADO I. ESPINO III TO ALLOCATE A SPACE FOR THE LINGAYEN MUNICIPAL LIBRARY (LML) IN THE HISTORICAL CASA REAL NEAR THE MUNICIPAL HALL BUILDING.

WHEREAS, Casa Real, a historical structure built in 1840, served as the first seat of the Provincial Government of Pangasinan;

WHEREAS, Casa Real was newly restored to become the province's repository of artifacts and items significant to the people of Pangasinan;

WHEREAS, a library is a museum of its own where some important pieces of history and large collection of books are stored;

WHEREAS, Section 7, Article III of the 1987 Philippine Constitution recognizes the right of the people to information, access to official records, and to documents and papers pertaining to official acts, transactions or decisions;

WHEREAS, RA 9460, otherwise known as the "National Archives of the Philippines Act of 2007" declares the policy of the state to protect, conserve, promote and popularize the nation's historical and cultural heritage and resources;

WHEREAS, the Lingayen Municipal Library occupies a limited space at the 2<sup>nd</sup> Floor of the Municipal Hall Building and it would be more convenient and conducive for learners, researchers and visitors alike, if it will be relocated to a more spacious and comfortable area;
