**RESOLUTION NO. 214, S-2020**

**AUTHORIZING THE MUNICIPAL MAYOR, HON. LEOPOLDO N. BATAOIL AND OIC-MUNICIPAL TREASURER, MRS. LILIBETH A. MANAOAT, TO OPEN A TRUST FUND/SAVINGS ACCOUNT/CHECKING ACCOUNT WITH THE PHILIPPINE VETERANS BANK, LINGAYEN BRANCH TO DEPOSIT, MAINTAIN AND MAKE WITHDRAWALS THEREFROM.**

WHEREAS, one of the primordial concern of the current administration is the establishment of a Scholarship Program for poor but deserving students;

WHEREAS, pursuant to Republic Act No. 109311 otherwise known as "Universal Access to Quality Tertiary Education Act", the Sangguniang Bayan of Lingayen enacted on September 30, 2019 Ordinance No. 78, S-2019, entitled, "An ordinance establishing a Scholarship Program through financial assistance in the Municipality of Lingayen, Pangasinan and appropriating funds relative thereto, also known as Lingayen Scholarship Program, sub-titled, "Iskolar ako ng Bayan";

Whereas, Section 6 (b) of Ordinance No. 78, S-2019 states that the OIC-Municipal Treasurer is required to open an account to deposit and keep the One Million Pesos budget for the Lingayen Scholarship Program and all other donations made relative thereto in the form of cash, checks, treasury warrants and money orders;

WHEREAS, as specified in Section 7 of the same ordinance, the Municipal Mayor as Chairman and the OIC-Municipal Treasurer as Treasurer of the Board shall be the signatories in all bank transactions;

WHEREAS, there is a need to open a separate bank account for this purpose for proper accounting procedures;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil and OIC-Municipal Treasurer, Mrs. Lilibeth A. Manaot to:

- (a) Transact business with the Philippine Veteran's Bank, Lingayen Branch, and open a trust fund/savings account/current account in the name of the Local Government Unit of Lingayen where the fund allocated for the Lingayen Scholarship Program and other monetary donations made relative thereto be deposited and kept;
- (b) To make withdrawals from the said account provided they shall bear the signatures of the Municipal Mayor and OIC-Municipal Treasurer;
- (c) To sign all forms, documents and agreements necessary for the purpose.


RESOLVED FURTHER, that copies of this resolution be furnished to the Municipal Mayor, OIC-Municipal Treasurer, Municipal Accountant, and Branch Manager of Philippine Veteran's Bank, Lingayen, Pangasinan for their information and files.


