RESOLUTION NO. 216, S-2020

REQUESTING DENR, CENRO, DAGUPAN CITY TO DECLARE AS ALIENABLE AND DISPOSABLE A PUBLIC LAND LOCATED AT DON VICENTE SOLIS STREET, LINGAYEN, PANGASINAN WITH AN AREA OF TWENTY TWO THOUSAND SQUARE METERS, AND FURTHER AUTHORIZING THE MUNICIPAL MAYOR TO APPLY FOR AN ENVIRONMENTAL COMPLIANCE CERTIFICATE FOR THE INTENDED PROJECTS OF THE MUNICIPAL GOVERNMENT.

WHEREAS, the Sangguniang Bayan received a letter from the Municipal Assessor requesting for the passage of a resolution requesting DENR, CENRO Dagupan City to declare as alienable and disposable a public land located at Don Vicente Solis Street, Lingayen, Pangasinan, covering an area of Twenty Two Thousand square meters;

WHEREAS, as provided under the 1987 Constitution, all public domain lands and natural resources belong to the State, and as such, the Local Government Unit of Lingayen has the right to own, possess, and develop said tract of land located within its territorial jurisdiction;

WHEREAS, the local government is in need of additional space particularly at the central business area, to put up its various economic and infrastructure projects to improve the economic well-being and quality of life of its inhabitants;

WHEREAS, the LGU intends to develop said parcel of land for various purposes such as expansion of market area to generate more income for the municipality; construction of multi-level parking to address the parking needs of private vehicles and to

ease traffic around downtown; and the construction of public utility terminal to serve as loading and unloading area for passengers and cargoes alike;

WHEREAS, the utilization of the land for municipal development projects will deter further proliferation of informal settlers in the area and will enable the local government to improve the location and the over-all well-being and welfare of those already residing thereat;

WHEREAS, to ensure that the would-be affected informal settlers will have a safe and decent place to move to, the municipal government shall establish and develop a relocation site to accommodate them, albeit, no movement or dismantling of structures shall be initiated not until the relocation area is ready for occupancy;

WHEREFORE, on motion of SBM John Silvester A. Tapia, duly seconded by SBM Ramon Anselmo M. Cuaresma, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request DENR, CENRO Dagupan City to declare as alienable and disposable a public land located at Don Vicente Solis Street, Lingayen, Pangasinan with an area of Twenty Two Thousand Square meters, and to further authorize the Municipal Mayor to apply for an Environmental Compliance Certificate for the intended projects of the Municipal Government.

RESOLVED FURTHER, that copies of this resolution be furnished to DENR, CENRO, Dagupan City, Pangasinan, and the Office of the Mayor for their information and appropriate action.
