RESOLUTION NO. 218, S-2020

AUTHORIZING THE MUNICIPAL MAYOR, HON. LEOPOLDO N. BATAOIL TO DIRECT ALL BARANGAY CAPTAINS TO CLEAR THE RIVER BANKS WITHIN THEIR AREAS OF JURISDICTION OF ILLEGAL FISHING STRUCTURES.

WHEREAS, Section 16, Article II of the Constitution enshrines the policy of the State to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Section 20 of Republic Act No. 9275 or the "Philippine Clean Water Act of 2004", states that the LGU shall share responsibility in the management and improvement of water quality within their territorial jurisdictions;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as The Local Government Code of 1991, states that every Local Government Unit (LGU) shall exercise the powers expressly granted for its efficient and effective governance, and those which are essential to the promotion of the general welfare, and that LGUs shall support the preservation and enrichment of culture, and enhance the right of the people to a balanced ecology;

WHEREAS, the illegal construction of fishing structures impedes the free flow and ebb off the tide in the municipal waters which causes siltation and pollution and contributes to perennial flooding in the municipality;

WHEREAS, the Local Disaster Risk Reduction and Management Office submitted a River Inspection Report dated October 24, 2019 with supporting pictures of illegal fishing structures in different barangays of the municipality, which was endorsed by the Local Chief Executive to the Sangguniang Bayan for the adoption of an appropriate resolution;

WHEREAS, the continued presence of these illegal fishing structures along the river banks of Lingayen affects the appearance of the rivers, upsets the ecological balance, and the water quality of nearby bodies of water, hence, the need to clear the river banks of these structures;

WHEREFORE, on motion of SBM Ramon Anselmo M. Cuaresma, duly seconded by SBMs Mac Dexter G. Malicdem and John Silvester A. Tapia, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor to direct all Barangay Captains to clear the river banks within their areas of jurisdiction of illegal fishing structures.

RESOLVED FURTHER, that copies of this resolution be furnished to the Office of Municipal Mayor, Honorable Leopoldo N. Bataoil, and the Barangay Captains of Lingayen for their information and appropriate action.


