### RESOLUTION NO. 227, S-2020

**AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPALITY, THE DEED OF DONATION TO BE ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF LINGAYEN AND THE DEPARTMENT OF HEALTH, REPRESENTED BY DR. VALERIANO JESUS V. LOPEZ, RELATIVE TO THE DONATION OF ONE (1) AMBULANCE TO THE MUNICIPALITY.**

WHEREAS, the State recognizes its mandate to provide equitable and accessible quality healthcare for all Filipinos;

WHEREAS, in view of the pandemic affecting the world, Lingayen is enhancing its defense by upscaling its health facilities, and medical equipments;

WHEREAS, to intensify the LGU's medical response, there is need for more ambulances and emergency vehicles which are needed for its health and emergency programs;

WHEREAS, as partners of Local Government Units, the Department of Health is committed in implementing health programs and delivering quality health services, hence, the donation of one (1) ambulance to the Municipality of Lingayen thru the initiative of Second District Congressman **JUMEL ANTHONY I. ESPINO**;

WHEREAS, for proper accounting of said donation, the Municipal Accountant Nelson S. Gumapos is likewise authorized to sign in the said Deed of Donation;
