RESOLUTION NO. 228, S-2020

REQUESTING THE DEPARTMENT OF TOURISM (DOT), DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), AND ALL CONCERNED AGENCIES TO FAST TRACK THE COMPLETION OF THE LIMAHONG CHANNEL TOURISM CENTER LOCATED AT BARANGAY PANGAPISAN NORTH, LINGAYEN, PANGASINAN.

WHEREAS, the Seventeenth Congress has declared the Limahong Channel located in the Municipality of Lingayen, Pangasinan as a tourist spot by virtue of House Bill No. 6682;

WHEREAS, a tourism development plan tagged as "Limahong Channel Tourism Center", a pet project of then Congressman of Second District of Pangasinan and now Municipal Mayor of Lingayen, Hon. Leopoldo N. Bataoil, was established to boost tourism, socio-economic industry and livelihood in the area;

WHEREAS, said project intends to enhance the beauty and splendor of Lingayen and to showcase its rich history and culture;

WHEREAS, the construction of the first phase of the development project, which is the Multi-Purpose Building is now underway with the DOT, DPWH, and DENR as lead implementing agencies;

WHEREAS, its fast completion will spur tourism industry in the province which was badly hit by the pandemic and provide work opportunities to townmates who were laid off from work or migrated back to the town via the Balik Probinsiya Program;
