RESOLUTION NO. 229, S-2020

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO UTILIZE THE TRAVELLING ALLOWANCE BUDGET FOR SENIOR CITIZEN PRESIDENTS AS FINANCIAL ASSISTANCE TO THEM FOR THE DURATION OF THE COMMUNITY QUARANTINE.

WHEREAS, it is the duty of the State to design programs of social security for Senior Citizens as provided for under Section 4, Article XV of the Constitution;

WHEREAS, in recognition of the rights of senior citizens to take their proper place in society, the Municipal Government of Lingayen has allocated a monthly travelling allowance for Senior Citizen Presidents in the amount of One Thousand Pesos (P1,000.00) to cover their travel expense as they go about performing their functions as leaders of their sector;

WHEREAS, amid the ongoing community quarantine, senior citizens are not allowed to go out due to their vulnerability to the Corona Virus Disease (COVID-19), thus hindering them from converging and attending meetings and other social obligations;

WHEREAS, since they have been deprived of their social and economic activities, these elderly leaders are having a hard time coping with their nutritional, financial and medical needs;

WHEREAS, in as much as the earmarked amount for travelling expense has not been utilized since the onset of the pandemic in March, same could be used as aid to the seniors to provide economic relief and to defray their expenses for food, medicines and other essential supplies;

WHEREAS, through this assistance, the LGU can manifest its care and support to the senior citizens of Lingayen who are feeling lonely, depressed and isolated because of the continuing effects of quarantine life;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Ramon Anselmo M. Cuaresma, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil to utilize the travelling allowance budget for Senior Citizen Presidents as Financial Assistance to them for the duration of the Community Quarantine.


RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the Municipal Mayor for his appropriate action, and the OSCA and Senior Citizens Federation Presidents for their information and records.


