CONFIRMING THE APPOINTMENT OF ENGR. JOHN SILVESTER A. TAPIA AS MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC), THIS MUNICIPALITY, LINGAYEN, PANGASINAN.

WHEREAS, Engr. John Silvester A. Tapia was appointed by the Municipal Mayor as Municipal Planning and Development Coordinator on July 1, 2020, whereafter his appointment was endorsed to the Sangguniang Bayan for confirmation on July 17, 2020;

WHEREAS, the vacant position of Municipal Planning and Development Coordinator is a mandatory position prescribed under Article VI, Section 476 of the Republic Act 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Section 443 (d) of the same Code provides that unless otherwise provided, heads of departments and offices shall be appointed by the municipal mayor with the concurrence of the majority of all the sangguniang bayan members, subject to Civil Service law, rules, and regulations;

WHEREAS, the appointee has been screened and found qualified by the majority of the Human Resource Merit Promotion and Selection Board (HRMPSB) during a deliberation held on June 29, 2020;

WHEREAS, being the lone applicant and due to the exigency of the service, the Sangguniang Bayan believes that the appointee is a good choice for the position and that he will be a valuable asset to the municipal government workforce;
