RESOLUTION NO. 232, S-2020

REQUESTING THE INTER-AGENCY TASK FORCE ON EMERGING INFECTIOUS DISEASES-PANGASINAN, THRU GOVERNOR AMADO I. ESPINO III, TO ALLOW THE MUNICIPALITY OF LINGAYEN TO ADJUST ITS CURFEW HOURS FROM 8:00 PM TO 5:00 AM TO 10:00 PM TO 4:00 AM.

WHEREAS, President Rodrigo Roa Duterte placed the island of Luzon under Enhanced Community Quarantine on March 16, 2020 to prevent the spread of COVID-19 and this was subsequently extended to May 15, 2020 in selected areas including the Province of Pangasinan;

WHEREAS, since May 16, 2020, Pangasinan has been placed under Modified General Quarantine by IATF-EID, which facilitates inter sectoral collaboration to establish preparedness and ensure efficient government response to assess, monitor, contain and prevent the spread of diseases;

WHEREAS, to protect its constituents from COVID-19, the Sangguniang Panlalawigan of Pangasinan enacted Provincial Ordinance No. 237, S-2020 on May 20, 2020 imposing curfew in the Province of Pangasinan from 8:00 PM to 5:00 AM, while the Honorable Council passed Ordinance No. 83, S-2020 on May 15, 2020 imposing the same curfew time in the municipality of Lingayen;

WHEREAS, the ongoing health crisis has affected many business companies in Lingayen especially those engaged in retail business, hotel and restaurant, travel and entertainment, due to the imposition of curfew hours in the locality;

WHEREAS, by virtue of IATF Resolution No. 48, S-2020, dine-in establishments were allowed to operate up to 9:00 PM provided they comply with social distancing and DTI protocols;

WHEREAS, with the adjustment of the curfew hours, the local economy will be revived and businessmen will enable to recoup from the beating of the corona virus disease;

WHEREAS, the Local Government Unit of Lingayen shall ensure that mandatory health and safety protocols are strictly observed so as not to compromise the health and well-being of its constituents;

WHEREFORE, on motion of SBM Ramon Anselmo M. Cuaresma, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request the Inter-Agency Task Force on Emerging Infectious Diseases-Pangasinan, thru Governor Amado I. Espino III, to allow the Municipality of Lingayen to adjust its curfew hours from 8:00 PM to 5:00 AM to 10:00 PM to 4:00 AM.


