THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on August 3, 2020, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 238, S-2020

DECLARING APPROPRIATION ORDINANCE NO. 1, S-2020 OF THE SANGGUNIANG BARANGAY OF DULAG, LINGAYEN, PANGASINAN OPERATIVE.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Lingayen, Pangasinan as a legislative body is empowered to review ordinances authorizing annual or supplemental appropriations of barangays in the manner prescribed by law;

WHEREAS, the Sangguniang Barangay of Dulag, Lingayen, Pangasinan submitted its Supplemental Budget No. 1, CY-2020, which was approved on July 6, 2020 through Appropriation Ordinance No. 1, S-2020;

WHEREAS, the Committee on Appropriation & Finance of the Sangguniang Bayan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, conducted preliminary review and study on said budget and hereby recommends to declare it OPERATIVE effective as of the date fixed in the Appropriation Ordinance subject however to the following condition, observation and recommendation:

1. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 or the Government Procurement Reform Act.

WHEREAS, the Sangguniang Bayan after final evaluation, finds the same in order;

WHEREFORE, on motion of Councilor Darwin B. Jimenez, duly seconded by Councilor Jay Mark Kevin D. Crisostomo, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Appropriation Ordinance No. 1, S-2020 of the Sangguniang Barangay of Dulag, Lingayen, Pangasinan operative.

RESOLVED FURTHER, that copies of this resolution be furnished the Municipal Budget Officer, Municipal Accountant, Municipal Treasurer and the Barangay Council of Dulag, this municipality, for their information and file.
