RESOLUTION NO. 241, S-2020

REALIGNING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FROM THE CAPITAL OUTLAY OF THE OFFICE OF MARKET AND SLAUGHTERHOUSE ORIGINALLY INTENDED FOR THE PURCHASE OF DETACHABLE TABLES FOR THE MARKET VENDORS TO THE FABRICATION/INSTALLATION OF DOOR GRILLS AT THE PUBLIC MARKET AMOUNTING TO ONE HUNDRED THOUSAND PESOS (P100,000.00), AND PURCHASE OF FIVE (5) COLLAPSIBLE TENTS AMOUNTING TO FOUR HUNDRED THOUSAND PESOS (P400,000.00).

WHEREAS, the amount of Five Hundred Thousand Pesos (P500,000.00) was appropriated under the Capital Outlay of the Office of the Market and Slaughterhouse in the approved Supplemental Budget No. 1, CY 2020 of the municipality of Lingayen, for the purchase of detachable tables for the market vendors (fruit/vegetable vendors);

WHEREAS, since the maintenance and upkeep of the public market facility is a primordial concern and the comfort and convenience of the market vendors and goers are of paramount importance, a necessity to realign the project title was deemed needed from the purchase of detachable tables for the market vendors to repair and maintenance of the public market and the purchase of five (5) collapsible tents for outdoor use;

WHEREAS, the change of project title will not affect the total amount originally appropriated in the supplemental budget along with its expenditure category;

WHEREAS, after careful consideration and evaluation by the Sangguniang Bayan, it was found out that the realignment is necessary and timely thereby granting its approval for the change of project title;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Randall Q. Bernal, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to realign the amount of Five Hundred Thousand Pesos (P500,000.00) from the capital outlay of the Office of Market and Slaughterhouse originally intended for the purchase of detachable tables for the market vendors to the fabrication/installation of door grills at the Public Market amounting to One Hundred Thousand Pesos (P100,000.00), and purchase of five (5) collapsible tents amounting to Four Hundred Thousand Pesos (P400,000.00).

RESOLVED FURTHER, that copies of this resolution be furnished to the Market Supervisor, Municipal Treasurer, Municipal Accountant, and Municipal Budget Officer, for their information and file.

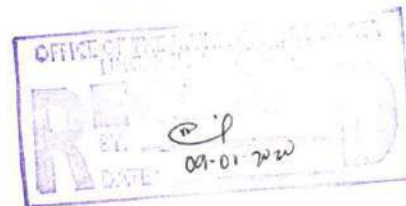
