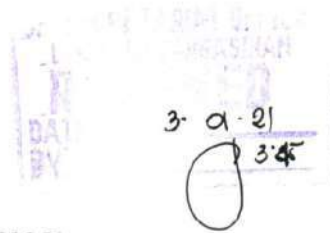

RESOLUTION NO. 242, S-2020

AUTHORIZING THE HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A DEED OF USUFRUCT WITH THE PHILIPPINE NATIONAL POLICE (PNP) AS TO THE USE OF MUNICIPAL LOTS FOR THE CONSTRUCTION OF POLICE COMMUNITY PRECINCTS (PCPs) IN THE MUNICIPALITY OF LINGAYEN.

WHEREAS, Section 5, Article II of the 1987 Constitution of the Philippines provides, that the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, the construction of the Police Community Precincts (PCPs) will add to police visibility to the areas and will redound to the benefit of the citizens to live peacefully and orderly;

WHEREAS, the Municipality of Lingayen and the Philippine National Police (PNP) jointly intends to construct the Police Community Precincts to three areas of this municipality;

WHEREAS, the construction of the Police Community Precincts will be funded by the Philippine National Police, and as its counterpart, the Municipality of Lingayen shall allocate lots for the construction of the same;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by SBMs Jay Mark Kevin D. Crisostomo and Ramon Anselmo M. Cuaresma, be it:
