RESOLUTION NO. 249, S-2020

GRANTING TEN THOUSAND PESOS (P10,000.00) CASH INCENTIVE TO CENTENARIANS LIVING IN THE MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN.

WHEREAS, Republic Act No. 10868, otherwise known as the Philippine Centenarians Act of 2016, grants a cash incentive of One Hundred Thousand Pesos (P100,000.00) to Senior Citizens who have reached the age of One Hundred (100) years old;

WHEREAS, relative to this Act, the Department of the Interior and Local Government issued Memorandum Circular No. 2016-160, enjoining Local Government Units to also grant cash incentives to centenarians in addition to the One Hundred Thousand Pesos (P100,000.00) cash award granted under RA No. 10868;

WHEREAS, the Municipality of Lingayen, through the Municipal Social Welfare and Development Office (MSWDO) is granting an additional cash incentive of Ten Thousand Pesos (P10,000.00) to centenarians from the funds of the Local Government, earmarked for the purpose;

WHEREAS, these incentives will serve to honor Senior Citizens who lived through a century, although posthumous awards will be given also to those who celebrated their 100th birthday upon the effectivity of this resolution but passed away before receiving the award;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to grant Ten Thousand Pesos (P10,000.00) cash incentive to centenarians living in the Municipality of Lingayen, Province of Pangasinan by virtue of DILG MC No. 2016-160, in addition to the One Hundred Thousand Pesos (P100,000.00) entitlement pursuant to RA No. 10868.

RESOLVED FURTHER, that copies of this resolution be furnished to the Municipal Mayor, the LGU Finance Committee, the MSWD Officer and the President of Senior Citizens of Lingayen for their information, guidance and reference.
