### RESOLUTION NO. 251, S-2020

ENDORING TO THE HONORABLE ANDREA B. DOMINGO, CHAIRPERSON AND CEO, PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR), THE IDENTIFIED PROPERTY OF THE MUNICIPAL GOVERNMENT OF LINGAYEN, PANGASINAN, WITH AN AREA OF TWENTY ONE THOUSAND THREE HUNDRED SEVENTY ONE (21,371) SQUARE METERS, OF WHICH THREE THOUSAND (3,000) SQUARE METERS WILL BE DEDICATED TO THE CONSTRUCTION OF THE PROPOSED EVACUATION CENTER LOCATED AT BARANGAY DOMALANDAN CENTER, THIS MUNICIPALITY.

WHEREAS, it is hereby declared the policy of the State to uphold the people's rights to life and property by addressing the cause of vulnerabilities to disasters and strengthening the institutional capacity or resilience of local communities to disasters;

WHEREAS, considering the high vulnerability of the Philippines to natural hazards, there is a need for every municipality to establish/construct evacuation centers to cater to the needs of the victims of calamities and provide temporary shelter to guarantee their safety and well-being;

WHEREAS, with the growing population of Lingayen, the existing evacuation centers which are mostly school buildings, could no longer accommodate the high volume of evacuees whenever calamities or disasters strike;

WHEREAS, in its desire to construct a calamity-resilient evacuation center that could address this concern, the Municipal Government searched and identified for this purpose a suitable area for the construction of an Evacuation Center;

WHEREAS, due to budgetary constraint, the LGU is incapable of undertaking the project on its own, much as it wants to;

WHEREFORE, on joint motion of SBM Jay Mark Kevin D. Crisostomo and SBM Ramon Anselmo M. Cuaresma, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to endorse to the Honorable Andrea B. Domingo, Chairperson and CEO, Philippine Amusement and Gaming Corporation (PAGCOR), the identified property of the Municipal Government of Lingayen, Pangasinan, with an area of Twenty One Thousand Three Hundred Seventy One (21,371) square meters, of which Three Thousand (3,000) square meters will be dedicated to the construction of the proposed Evacuation Center located at Barangay Domalandan Center, this municipality.


RESOLVED FURTHER, that copies of this resolution be furnished to the Honorable Andrea B. Domingo, PAGCOR House, 1330 Roxas Blvd. Ermita, Manila, and to the Municipal Mayor for their information and appropriate action.
