### RESOLUTION NO. 252, S-2020

AUTHORIZING THE HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A DEED OF USUFRUCT WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) FOR THE USE OF A PORTION OF LOT IN THE LIMAHONG CHANNEL TOURISM AND GOVERNMENT CENTER, BARANGAY PANGAPISAN NORTH, THIS MUNICIPALITY.

WHEREAS, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the National Health Insurance Program was established to provide health insurance coverage and ensure affordable, acceptable, accessible, health care services to the citizens of the Philippines;

WHEREAS, the establishment of PhilHealth Offices in strategic locations enable the agency to provide accessible services to its members for their satisfaction and overall accomplishments of program objectives;

WHEREAS, PhilHealth, thru its President and CEO, wrote a letter to the Local Chief Executive expressing their desire to put-up their own building to accommodate the PhilHealth Regional Office in Lingayen with a required lot area of at least 2,500 square meters capable of servicing PhilHealth's local and satellite offices;

WHEREAS, a portion of land is available at the Limahong Channel Tourism and Government Center which is ideal for the establishment of PhilHealth Office and construction of building that will enhance the efficiency of service of PRO I in catering to 125 Local Government Units and its accredited Health Care Institutions and Health Care Professionals;

WHEREAS, the Sanggunian finds the Deed of Usufruct beneficial to the municipality considering that the presence of said facility in the Government Center will ensure the fast delivery of accessible and quality health care to its beneficiaries in Lingayen and nearby cities and municipalities in times of contingencies;

WHEREFORE, on motion of SBM Ramon Anselmo M. Cuaresma, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Honorable Mayor Leopoldo N. Bataoil to enter into a Deed of Usufruct with the Philippine Health Insurance Corporation (PhilHealth) for the use of a portion of lot in the Limahong Channel Tourism and Government Center, Barangay Pangapisan North, this municipality.

RESOLVED FURTHER, that copies of this resolution be furnished to the Municipal Mayor, the Regional President of PhilHealth, the Municipal Assessor, and all concerned agencies/offices for their information and appropriate action.
