RESOLUTION NO. 261, S-2020

AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE STATISTICS AUTHORITY RELATIVE TO THE IMPLEMENTATION OF THE PHILIPPINE IDENTIFICATION SYSTEM OR PHILSYS REGISTRATION.

WHEREAS, Philippine Statistics Authority was established by virtue of Republic Act No. 10625 or the Philippine Statistical Act of 2003 to centralize processing and publishing of official data and statistics and to improve the quality and timeliness of official statistics as well as generate efficiencies in data collection;

WHEREAS, Republic Act 11055 created the Philippine Identification System or "PhilSys" for the establishment of a single national identification system to register all Filipinos and resident aliens of the Republic of the Philippines for easier accessibility and application for eligibility to social welfare programs and benefits from the government;

WHEREAS, Section 15 of the Implementing Rules and Regulations (IRR) of RA 11055 vested PSA the primary implementation of PhilSys and empowered it to collaborate with Local Government Units (LGUs), other government agencies, and GOCCs to ensure the registration and enrolment of all citizens and residents aliens in the PhilSys including Indigenous Cultural Communities/Indigenous Peoples and those located in remote localities;

WHEREAS, the PhilSys Policy Coordinating Council (PSPCC), recognizes the need for LGUs assistance in implementing the national identification system because of their familiarity with the people and conditions in their territorial jurisdictions;

WHEREAS, all LGUS and Regional DILG Offices are enjoined to provide assistance in the implementation of PhilSys registration in their respective localities;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, be it:


RESOLVED AS IT IS HEREBY RESOLVED, to authorize Honorable Mayor Leopoldo N. Bataoil to:

- (a) Enter into a Memorandum of Agreement with the Philippine Statistics Authority relative to the implementation of the Philippine Identification System or PhilSys Registration, under such terms and conditions beneficial to the Municipality of Lingayen.
- (b) To sign the Memorandum of Agreement and all forms, documents, and agreements necessary for the above-stated purpose.

RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the Municipal Mayor, the Pangasinan Provincial Statistical Office, and the Local Civil Registrar, for their information and records.
