### RESOLUTION NO. 262, S-2020

AUTHORIZING MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOCOS TRAINING AND REGIONAL MEDICAL CENTER FOR THE CONDUCT OF MASS TESTING FOR COVID-19 (SARS-COV-2) OF THE CONSTITUENTS OF LINGAYEN, PANGASINAN.

WHEREAS, the Municipality of Lingayen desires to provide mass testing for its constituents to stem the spread of COVID-19;

WHEREAS, the Ilocos Training and Regional Medical Center (ITRMC) was designated by the Department of Health, Center of Health Development I, as a COVID-19 (SARS-CoV-2) testing laboratory for emerging and re-emerging infectious diseases;

WHEREAS, ITRMC's Molecular Laboratory was certified by the Research Institute for Tropical Medicine (RITM) as capable of performing independent testing center for COVID-19 (SARS-CoV-2) by Realtime RT-PCR;

WHEREFORE, on motion of SBM Ramon Anselmo M. Cuaresma, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Honorable Mayor Leopoldo N. Bataoil to:

- (a) Enter into a Memorandum of Agreement with the Ilocos Training and Regional Medical Center or its duly authorized representative for the conduct of mass testing of the constituents of Lingayen, Pangasinan, under such terms and conditions beneficial to the Municipality of Lingayen.



(b) To sign the Memorandum of Agreement and all forms, documents, and agreements necessary for the above-stated purposes.
