RESOLUTION NO. 263-A, S-2020

AUTHORIZING HON. LEOPOLDO N. BATAOIL, MUNICIPAL MAYOR, LINGAYEN PANGASINAN TO ENTER INTO, SIGN AND EXECUTE AN IMPLEMENTATION AGREEMENT WITH THE SOCIAL SECURITY SYSTEM (SSS) REGARDING THE COVERAGE OF ALL JOB ORDERS AND CONTRACTUAL PERSONNEL OF THE MUNICIPALITY UNDER THE SSS SELF-EMPLOYED MEMBERSHIP PROGRAM.

WHEREAS, Alaminos Branch Head Mr. Jose Alvin M. Altre visited this Honorable Body to present and discuss regarding the Memorandum of Agreement (MOA), entered into by former SSS President and CEO Emilio S. De Quiros Jr. and former Secretary of the Department of the Interior and Local Government (DILG), Secretary Mar Roxas dated February 12, 2014;

WHEREAS, the aforementioned Memorandum of Agreement (MOA) allows Job Orders and Contractual Personnel of Local Government Units (LGUs), who are not members of the Government Service Insurance System (GSIS) to register as Self-Employed SSS members;

WHEREAS, in order to implement the agreement, Roxas issued a directive thru Memorandum Circular No. 2014-83 dated July 18, 2014 to all LGUs to encourage Job Orders and Contractual Personnel to enrol in the SSS Protection;

WHEREAS, the program provides social security to its Job Orders and Contractual Employees against the hazards of disability, sickness, maternity, old age, death and other contingencies that SSS offers;

WHEREFORE, on joint motion of SBM Ricardo R. Ferrer and SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Leopoldo N. Bataoil, Municipal Mayor, Lingayen, Pangasinan to enter into, sign and execute an Implementation Agreement with the Social Security System (SSS) regarding the coverage of all Job Orders and Contractual Personnel of the municipality under the SSS Self-Employed Membership Program.
