**RESOLUTION NO. 263, S-2020**

**REQUESTING CENTRAL PANGASINAN ELECTRIC COOPERATIVE (CENPELCO) TO AVOID POWER OUTAGES DURING WEEKDAYS WHEN ONLINE CLASSES ARE IN PROGRESS AND TO ENSURE SUFFICIENT AND STABLE SUPPLY OF ELECTRICITY DURING THIS COVID CRISIS.**

WHEREAS, the General Welfare Clause of the Local Government Code of 1991 provides that every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, one of the important thrusts of the current administration this time of pandemic is to make education accessible to all especially with the inception of online learning;

WHEREAS, to achieve this, the LGU relies on its partner service providers to ensure that students have the basic tools and resources needed for e-learning;

WHEREAS, the constant unannounced and ill-timed power outages by CENPELCO causes undue interference to online classes thereby affecting the efficiency in the instructional and learning process;

WHEREAS, the provision of steady and reliable electricity supply will boost the effectiveness of distance and online learning and the revival of the local economy;

WHEREFORE, on motion of SBM Ricardo R. Ferrer, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Central Pangasinan Electric Cooperative (CENPELCO) to avoid power outages during weekdays when online classes are in progress and to ensure sufficient and stable supply of electricity during this COVID crisis.


RESOLVED FURTHER, that copies of this resolution be furnished to the General Manager of CENPELCO thru the Area Manager of Lingayen for their information and appropriate action.


