RESOLUTION NO. 266, S-2020

AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) FOR THE UTILIZATION OF THE MUNICIPAL SHARE FROM SMALL-TOWN LOTTERY (STL) TO HEALTH PROGRAMS, MEDICAL ASSISTANCE AND CHARITABLE SERVICES.

WHEREAS, the PCSO is the principal government agency mandated to raise and provide funds for health programs, medical assistance and services, and charities of national character, through the conduct of sweepstakes, races, nationwide online lottery (Lotto), Small Town Lottery (STL) and other similar activities;

WHEREAS, the LGU is recognized as a vital instrument in providing the needed medical and health services to its constituents;

WHEREAS, in pursuit of its mandate and aligned with the President's programs, the PCSO is committed to provide LGUs with a portion of the charity fund generated from the sales of LOTTO and STL within their jurisdiction;

WHEREAS, PCSO also provides calamity assistance to LGUs in times of natural calamities and disasters, including those caused by outbreaks, epidemics and pandemics, under the calamity assistance program of PCSO;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Honorable Mayor Leopoldo N. Bataoil to enter into a Memorandum of Agreement (MOA) with the Philippine Charity Sweepstakes Office (PCSO) for the utilization of the municipal share from Small-Town Lottery (STL) to health programs, medical assistance and charitable services.

RESOLVED FURTHER, that copies of this resolution be furnished the Municipal Mayor, the General Manager of PCSO, and the Municipal Treasurer for their information and guidance.


