RESOLUTION NO. 267, S-2020

AUTHORIZING HONORABLE LEOPOLDO N. BATAOIL, MUNICIPAL MAYOR, TO SIGN THE DEED OF DONATION AND ACCEPTANCE FOR AND IN BEHALF OF THE MUNICIPALITY OF LINGAYEN, WITH THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) RELATIVE TO THE DONATION OF AN AMBULANCE UNDER THE PCSO PTV PROGRAM.

WHEREAS, presented to the Body for legislative consideration is the request of the Municipal Mayor for authority to sign the Deed of Donation and Acceptance of ambulance under the PCSO PTV Program;

WHEREAS, the Patient Transport Vehicle Donation Program is one of the key programs of the PCSO to equip Local Government Units, Government Hospitals, Municipal Health Offices and other health institutions/facilities all over the country with medical transport vehicles to immediately respond to the needs of patients especially from poverty-stricken areas;

WHEREAS, in the face of the global pandemic due to coronavirus disease and the unexpected surge in the number of cases within the municipality, the Local Government of Lingayen is giving its best efforts in the health and well-being of its constituents by protecting them from the dangers of the disease, especially old and young people, and those with pre-existing medical conditions, and in helping those already afflicted;

WHEREAS, relative to this, the LGU is desirous to avail of the PTV Program in order to be more responsive, efficient and quick in dealing with various health emergency situations that are in dire need of immediate medical attention and relief to alleviate pain and suffering and to ultimately save lives;

WHEREAS, one of the requirements needed to avail the program is a Sangguniang Bayan resolution authorizing the Mayor to sign the Deed of Donation and Acceptance, and since the same is provided under Section 444 (b) (vi) of RA 7160, otherwise known as the Local Government Code of 1991, the Council hereby grants the authorization;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Honorable Leopoldo N. Bataoil, Municipal Mayor, to sign the Deed of Donation and Acceptance for and in behalf of the Municipality of Lingayen, with the Philippine Charity Sweepstakes Office (PCSO) relative to the donation of an ambulance under the PCSO PTV Program.
