THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on October 5, 2020, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 269, S-2020

DECLARING BARANGAY TAX ORDINANCE NO. 1, S-2019 OF THE SANGGUNIANG BARANGAY OF ESTANZA, LINGAYEN, PANGASINAN, ENTITLED, "AN ORDINANCE ENACTING THE REVISED BARANGAY OMNIBUS TAX CODE OF BARANGAY ESTANZA, LINGAYEN, PANGASINAN AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Estanza, Lingayen, Pangasinan, submitted its Barangay Tax Ordinance No. 1, S-2019 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (A) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;


WHEREAS, the Committee on Laws and Human Rights of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Barangay Council of Estanza shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;


WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Ramon Anselmo M. Cuaresma, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Barangay Tax Ordinance No. 1, S-2019 of the Sangguniang Barangay of Estanza, Lingayen, Pangasinan, entitled "An ordinance enacting the revised Barangay Omnibus Tax Code of Barangay Estanza, Lingayen, Pangasinan and providing penalties thereof" as within the conferred powers of the Sangguniang Barangay to enact.
