**RESOLUTION NO. 271, S-2020**

**REQUESTING HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ISSUE AN EXECUTIVE ORDER TEMPORARILY CLOSING ALL PUBLIC AND PRIVATE CEMETERIES IN THE MUNICIPALITY OF LINGAYEN FROM OCTOBER 29 TO NOVEMBER 4, 2020.**

WHEREAS, All Saints' Day and All Souls' Day, held on the first and second day of November, are important occasions to predominantly Catholic Filipinos dedicated to celebrating the life, faith and martyrdom of all Christian saints and to honoring and remembering the departed loved ones;

WHEREAS, the tradition and culture of "*Undas*" in the Philippines is celebrated to give respect to the dead and to pray for the souls of deceased family members and relatives who have crossed over to the afterlife;

WHEREAS, due to the coronavirus pandemic, the Inter-Agency Taskforce for the Management of Emerging Infectious Diseases has issued Resolution No. 71 which in effect prevented the observance of All Souls' Day and All Saints' Day for this year;

WHEREAS, according to the Order all public and private cemeteries including Memorial Parks and Columbarium shall be closed to visitors from October 29 to November 4, 2020;

WHEREAS, to prevent further spread of the virus, the close off has to be made to discourage mass gatherings and the influx of visitors to the cemeteries;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Mayor Leopoldo N. Bataoil to issue an Executive Order temporarily closing all Public and Private Cemeteries in the Municipality of Lingayen from October 29 to November 4, 2020.

RESOLVED FURTHER, that a copy of this resolution be furnished to the Municipal Mayor for his information and appropriate action.

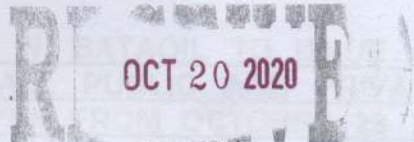
