RESOLUTION NO. 274, S-2020

REQUESTING HONORABLE NESTOR G. RILLON, RDC VICE CHAIRPERSON AND NEDA REGIONAL DIRECTOR, TO ALLOCATE FUNDS IN THE AMOUNT OF SEVEN HUNDRED FIFTY MILLION (P750,000,000.00) PESOS FOR THE CONSTRUCTION OF LIMAHONG BRIDGE WHICH WILL CONNECT BARANGAY PANGAPISAN NORTH AND BARANGAY CAPANDANAN, THIS MUNICIPALITY.

WHEREAS, Barangays Pangapisan North and Capandanan are two barangays in Lingayen separated by the Limahong Channel located along the Agno River;

WHEREAS, the construction of the Limahong Bridge that will link the two barangays is a priority project of the current administration in order to enhance socio-economic development and tourism growth in the area;

WHEREAS, the proposed structure measuring 300 meters long will ease traffic congestion in the major highways of the town and improve the movement of goods and services for the people especially the residents of western barangays;

WHEREAS, it is incumbent upon LGUs to provide effective and efficient delivery of services and facilities in the local level;

WHEREAS, the Municipality of Lingayen lacks the financial capability to implement the project;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Nestor G. Rillon, RDC Vice Chairperson and NEDA Regional Director, to allocate funds in the amount of Seven Hundred Fifty Million (P750,000,000.00) Pesos for the construction of Limahong Bridge which will connect Barangay Pangapisan North and Barangay Capandanan, this municipality.


