RESOLUTION NO. 279, S-2020

ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY PLAN FOR CY 2020-2022 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, in accordance to DILG Memorandum Circular No. 2011-024, which aims to further strengthen the Peace and Order Councils and Barangay Peace and Order Councils in tackling peace and order and public safety in the localities, and to Republic Act 6975, which mandates the development and establishment of an integrated area/community public safety plan embracing priorities of action and program thrusts for implementation by the Philippine National Police Stations, the Department of the Interior and Local Government issued DILG Memorandum Circular No. 2015-128, "Guidelines on the Formulation of the Peace and Order and Public Safety Plan";

WHEREAS, in compliance with these issuances, the Municipal Peace and Order Council of the Municipality of Lingayen, Pangasinan duly formulated the Peace and Order and Public Safety Plan (POSP) CY 2020-2022 and transmitted the same to the August Body for adoption;

WHEREAS, the POSP Plan is a three-year term-based plan which shall be incorporated in the Comprehensive Development Plan (CDP) of the Local Government Unit (LGU) to be formulated and approved by the Peace and Order Council (POC) to improve life in the communities by ensuring social protection and safety;

WHEREAS, after perusal and deliberation of the submitted plan, the August Body found it to be vital in addressing the gaps on peace and order and public safety concerns and issues in the municipality with the end view of sustaining and enhancing its over-all peace and order situation;

WHEREFORE, on motion of SBM Randall Q. Bernal, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:


RESOLVED FURTHER, that copies of this resolution be furnished to concerned agencies for their information and guidance.
