THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on July 30, 2019, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 28, S-2019

DECLARING TAX ORDINANCE NO. 01, S-2019 OF THE SANGGUNIANG BARANGAY OF ROSARIO, LINGAYEN, PANGASINAN, ENTITLED, ORDINANCE IMPLEMENTING SECTION 152 OF REPUBLIC ACT NO. 7160 (THE LOCAL GOVERNMENT CODE OF 1991), THE COLLECTION TAXES ON ALL WHOLESALERS, STORES, SARI-SARI STORES, RETAILERS, OTHER COMMERCIAL OR TRADE ACTIVITIES WITH VIEW TO PROFIT, WITH FIXED BUSINESS ESTABLISHMENTS AND WITH GROSS SALES OR RECEIPTS OF THE PRECEDING CALENDAR YEAR OF THIRTY THOUSAND PESOS (P30,000.00) OR LESS AT A RATE NOT EXCEEDING (1%) ON SUCH GROSS SALES OR RECEIPTS AND IMPOSING TAXES, FEES, AND CHARGES ON AMUSEMENT AND RECREATIONAL ACTIVITIES (INTERNET, PESONET, VIDEOKE STANDS, BILLIARDS, TABLE POOLS) AND OTHER RELATED TRADE AND COMMERCIAL ACTIVITIES ENGAGED IN AS MEANS OF LIVELIHOOD OR WITH A VIEW TO PROFIT, BARANGAY CERTIFICATIONS, CLEARANCES AND PERMITS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Rosario, Lingayen, Pangasinan, submitted its Tax Ordinance No. 01, S-2019 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (A) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Barangay Council of Rosario shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by SBM Jonathan Carl R. Arcinue, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Tax Ordinance No. 01, S-2019 of the Sangguniang Barangay of Namolan, Lingayen, Pangasinan, entitled "An ordinance implementing Section 152 of Republic Act No. 7160 (The Local Government Code of 1991), the collection of taxes on all wholesalers, stores, sari-sari stores, retailers, other commercial or trade activities with a view to profit, with fixed business establishments and with gross sales or receipts of the preceding calendar year of Thirty Thousand Pesos (P30,000.00) or less at a rate not exceeding (1%) on such gross sales or receipts and imposing taxes, fees and charges on amusement and recreational activities (internet, pesonet, videoke stands, billiards, table pools) and other related trade and commercial activities engaged in as means of livelihood or with a view to profit, barangay certifications, clearances and permits", as within the conferred powers of the Sangguniang Barangay to enact.

RESOLVED FURTHER, that copies of this resolution be furnished the Municipal Accountant, Municipal Treasurer-ICO, and the Barangay Council of Rosario, this municipality, for their information and file.
