### RESOLUTION NO. 280, S-2020

REQUESTING HONORABLE SECRETARY WENDEL E. AVISADO OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FIFTY MILLION PESOS (P50,000,000.00) FOR THE ASPHALT OVERLAY OF LOCAL ACCESS ROAD IN THE WESTERN BARANGAYS OF LINGAYEN, PANGASINAN.

WHEREAS, Lingayen, the capital town of Pangasinan and the seat of government of the province has thirty-two (32) barangays, nine (9) of which are situated on the western part;

WHEREAS, the Municipal government of Lingayen is committed in enhancing its road infrastructures as an important means to enhance access and movement of people and goods from far-flung barangays to the town proper;

WHEREAS, by strengthening its road networks more visitors and investors will come to Lingayen to explore and invest in its growing economy which will help advance the socio-economic development initiatives of the administration;

WHEREAS, the construction of an access road for the western barangays of Lingayen will yield robust growth in the area, create better economic opportunities, and improve the living conditions of the local dwellers;

WHEREAS, this road infrastructure project could be attained with the intervention and support of the Department of Budget and Management (DBM) which overlooks the efficient and sound utilization of government funds and provides financial allocations to locally initiated development schemes;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Secretary Wendel E. Avisado of the Department of Budget and Management (DBM) to allocate Fifty Million Pesos (P50,000,000.00) for the asphalt overlay of local access road in the western barangays of Lingayen, Pangasinan.

RESOLVED FURTHER, that a copy of this resolution be furnished to Secretary Wendel E. Avisado, General Solano Street, San Miguel, Manila, for his appropriate action.
