RESOLUTION NO. 281, S-2020

REQUESTING HONORABLE WENDEL E. AVISADO, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE TWENTY MILLION PESOS (P20,000,000.00) FOR THE INSTALLATION OF SOLAR STREETLIGHTS IN BARANGAYS LIBSONG EAST AND LIBSONG WEST, THIS MUNICIPALITY.

WHEREAS, Lingayen, the capital town of Pangasinan is fast becoming a favorite tourist destination in the region not only for its beautiful and serene beach and the grandiose Provincial Capitol but also for its famous food products, recreational sites and accommodating people;

WHEREAS, the town's economy is also growing in leaps and bounds due to the unwavering and collective efforts of the officials and residents who work in unison to achieve its socio-economic targets;

WHEREAS, Barangays Libsong West and Libsong East are urban areas situated near the town proper with an approximately combined population of over Twelve Thousand people;

WHEREAS, due to the proximity of said barangays to Poblacion and to the commercial and government offices, it has become the go to places of young professionals seeking for greener opportunities and employment, newly married couples looking for apartments and houses, and entrepreneurs looking for business locations;

WHEREAS, there is a need to light up said barangays with solar lights to enhance their urban appeal, provide security and safety to its dwellers and prevent crimes and accidents from happening;

WHEREAS, the municipal government has limited financial capability to implement the development project, hence the need to seek the assistance of DBM;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly second by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Wendel E. Avisado, Secretary of the Department of Budget and Management (DBM) to allocate Twenty Million Pesos (P20,000,000.00) for the installation of solar streetlights in Barangays Libsong East and Libsong West, this municipality.


