RESOLUTION NO. 288, S-2020

APPROVING THE ACCREDITATION OF JUNIOR CHAMBER INTERNATIONAL LINGAYEN BAGOONG AS A CIVIL SOCIETY ORGANIZATION (CSO) IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, Article 62 of the Rules and Regulations Implementing RA 7160 expressly provides that the Local Government Unit (LGU) shall promote the establishment and operation of People's Organizations (POs), Non-Governmental Organizations (NGOs), Socio-Civic Groups, associations of professionals and related associations which are all categorized as Civil Society Organizations, and to make them active partners in the pursuit of local autonomy;

WHEREAS, DILG Memorandum Circular 2010-73 provides that accreditation is a continuing process wherein People's Organizations (POs), Non-Governmental Organizations (NGOs) and business or professional group may apply and obtain accreditation at any time; the only legal effect of not applying for accreditation within the period prescribed by law is that such organization is not entitled for a representation in a local special body;

WHEREAS, Civil Society Organizations (CSOs) are partners of the Local Government Units in the implementation of laws and programs for Local Governance in the barangays and municipality, and in order for them to be legitimately represented in Special Bodies, Article 64 of the IRR of RA 7160 have empowered the Sangguniang Bayan to accredit them provided they have complied with the procedures and necessary documentation for accreditation;

WHEREAS, submitted before this Body is the application for accreditation of Junior Chamber International Lingayen Bagoong for membership in the local special bodies;

WHEREAS, after careful review of the submitted requirements, the Committee on Accreditation hereby recommends for the accreditation of said organization considering that it has satisfactorily complied with all the requirements as mandated in Article 64 of the IRR of RA 7160, and after ascertaining that their programs/projects have significant impact in the Local Government Unit of Lingayen;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it;

RESOLVED AS IT IS HEREBY RESOLVED, to approve the accreditation of Junior Chamber International Lingayen Bagoong as a Civil Society Organization (CSO) in the Municipality Lingayen.
