FAVORABLY ENDORSING THE APPLICATION OF RAEK KITZ CORPORATION (CENTRUM FUEL) TO CONSTRUCT AND OPERATE A GASOLINE SERVICE STATION AT BARANGAY QUIBAOL, THIS MUNICIPALITY.

WHEREAS, the Local Chief Executive and Zoning Officer of this municipality indorsed to the Sangguniang Bayan for legislative action, the letter intent of Rael Kitz (Centrum Fuel) to put-up a Gasoline Service Station at Brgy. Quibaol, Lingayen, Pangasinan;

WHEREAS, upon scrutiny of the supporting papers, it was found out that the applicant has sufficiently complied with the documentary requirements necessary for the construction of the gasoline station;

WHEREAS, the legislative action of the Sanggunian is in pursuant to Section 447 (a) of RA 7160, which states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code, and in the proper exercise of its corporate powers as provided for under Section 22 of the same code;

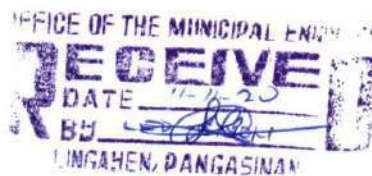
