### RESOLUTION NO. 29, S-2019

**A RESOLUTION REQUESTING HONORABLE CHRISTOPHER LAWRENCE "BONG" T. GO, SENATOR OF THE REPUBLIC OF THE PHILIPPINES, TO ALLOCATE FUNDS AMOUNTING TO 120 MILLION FOR THE PURCHASE OF LOT LOCATED AT SOLIS STREET, BRGY. POBLACION, LINGAYEN, PANGASINAN, INTENDED FOR THE CONSTRUCTION OF THE LINGAYEN STADIUM.**

WHEREAS, Lingayen has many homegrown talents from the grassroots waiting to be discovered in the national scene especially in the field of sports;

WHEREAS, at present, the LGU does not have a sizeable sports facility of its own that can cater to the sporting needs of its young people that will help them stay clear from drugs, vices and alcoholism;

WHEREAS, the presence of a sports stadium in the municipality will be a big boost for the capital town to host national sporting events, international competitions, seminars and conventions, and concerts of popular artists;

WHEREAS, the municipal government has earmarked a lot intended for the Lingayen Stadium that is estimated at a cost of One Hundred Twenty (P120M) Million including land fill at Solis Street, Brgy. Poblacion, Lingayen, Pangasinan;

WHEREAS, the municipality has no available funds for the purpose and is soliciting for financial assistance from outside sources especially from benevolent higher officials to assist the LGU realize its project;

RESOLVED AS IT IS HEREBY RESOLVED, to request Honorable Christopher Lawrence "Bong" T. Go, Senator of the Republic of the Philippines, to allocate funds amounting to One Hundred Twenty (P120M) Million for the purchase of lot located at Solis Street, Brgy. Poblacion, Lingayen, Pangasinan, intended for the construction of the Lingayen Stadium.
