WHEREAS, PCSO is a Government Owned and Controlled Corporation (GOCC) mandated to undertake fund raising and fund support for health programs, medical assistance and charities of national character;

WHEREAS, PCSO Pangasinan thru its Manager expressed its intention to transfer their office from Urdaneta City to Lingayen town by way of a courtesy visit to the Office of the Local Chief Executive;
