APPROVING RESOLUTION NO. 292, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) FOR CY 2020 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Resolution No. 292, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Lingayen, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on October 7, 2020 by the Municipal Development Council through Resolution No. 04, S-2020 and was favorably acted upon by the Sangguniang Bayan on November 5, 2020 thru SB Resolution No. 292, S-2020;

WHEREAS, the Supplemental Investment Program No. 2 of the municipality covers the fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of municipal offices and market and slaughterhouse, disaster risk reduction and management activities and development projects of the Municipality of Lingayen;

WHEREAS, the development projects proposed to be funded from the realigned 20% development fund are based on the DILG-DBM JMC No. 107-1, dated February 22, 2017 "Updated Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects";


