RESOLUTION NO. 155-2021

APPROVING RESOLUTION NO. 293, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2021 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Resolution No. 293, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Lingayen, Pangasinan had identified and prioritized programs and projects in the municipality's Annual Investment Program for Calendar Year 2021. This was endorsed to the Sangguniang Bayan for approval on October 7, 2020 thru MDC Resolution No. 5, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Lingayen, Pangasinan was formulated following the prescribed AIP Summary Form and covers: a) all the regular budgetary requirements for the operations of the different municipal offices broken down into: Personal Services

(PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction programs, projects and activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Gender and Development Plan, g) Annual Procurement Plan, h) Annual Cultural Plan, i) Nutrition Action Plan, and j) list of programs/projects/activities for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and PPAs to combat AIDS and PPAs to address the problem on illegal drugs;

WHEREAS, the proposed AIP of Lingayen CY 2021 has a total investment requirement of P7,515,910,090.00. Funding support for the implementation of which is embodied in their proposed Annual Budget for CY 2021 in the amount of P326,081,090.00, which was passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 3, S-2020 dated November 9, 2020. The remaining amount of P7,189,829,000.00 is proposed for funding from national government agencies and other fund sources;

WHEREAS, this is also in accordance with Section 287 of RA 7160. More than 20% or about 20.3% of the LGU's IRA (P256,081,090.00), which is equivalent to P52,000,000.00 is allocated for development projects. These development projects are in conformity with Joint DBM-DOF-DILG Joint Memorandum Circular 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects);

WHEREAS, the Disaster Risk Reduction and Management Plan, in preparation for and to mitigate the impact of disasters, proposed to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P15,154,100.00 is in conformity to Section 21 of RA 10121. The proposed programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P10,607,870.00 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRM Plan of the municipality was submitted to the Office of the Civil Defense (OCD) for review;

WHEREAS, the LGU of Lingayen had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) of the municipality were reviewed by the Department of Interior and Local Government Provincial Office and were found to be fully compliant in form and in contents with the provisions of DBM-PCW-DILG-NEDA Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;



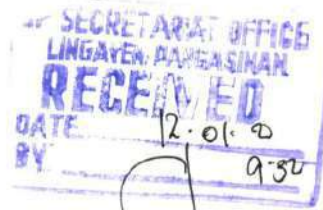
