RESOLUTION NO. 297, S-2020

DESIGNATING THE EXISTING BANK ACCOUNT OF THE MUNICIPALITY OF LINGAYEN WITH CURRENT ACCOUNT NO. 0038-011369-002, MAINTAINED AT THE PHILIPPINE VETERAN'S BANK (PVB), LINGAYEN BRANCH, AS THE DEPOSITORY ACCOUNT FOR ALL CASH DONATIONS TO THE MUNICIPAL GOVERNMENT OF LINGAYEN, PANGASINAN.

WHEREAS, the Sangguniang Bayan is in receipt of a letter coming from the Municipal Mayor, Honorable Leopoldo N. Bataoil, requesting for a resolution designating one bank account of the municipality as depository account for all cash donations;

WHEREAS, a bank account under the name of the municipality with Current Account No. 0038-011369-002, was opened by the Municipal Treasurer at the height of the Enhanced Community Quarantine with the Philippine Veteran's Bank (PVB), Lingayen, Pangasinan, through SB Resolution No. 200, S-2020, which served as a depository account for monetary donations to the LGU relative to the COVID-19 pandemic;

WHEREAS, due to the onslaught of Typhoon Ulysses in most parts of Luzon, 1.7 Million Filipinos were directly affected particularly in the provinces of Cagayan, Isabela and Rizal, and the City of Marikina which suffered widespread destruction and massive flooding;

WHEREAS, heeding the call for help of the affected people, the Municipal Government of Lingayen has launched a donation campaign dubbed as "Lingap Lingayen Donation Drive" to assist the victims of Typhoon Ulysses in this trying time and to help them recover from its aftermath;

WHEREAS, in response to the call for donations by the municipality, many people from Lingayen and outside places donated goods, used clothing, and cash assistance which clearly manifested the Lingayenenses' kind heartedness and empathy to their suffering fellowmen;

WHEREAS, aside from donations for the Typhoon Ulysses victims, several other well-meaning friends and supporters of the LGU are extending financial aid to the municipality for its own disaster prevention, mitigation, and relief programs;

WHEREAS, to facilitate proper disbursement of received funds, all cash donations relative to Typhoon Ulysses will be deposited in the existing current account of the municipality with the Philippine Veteran's Bank (PVB), Lingayen Branch, under Current Account No. 0038-011369-002, which will now serve as depository account for all cash donations of the municipality;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to designate the existing bank account of the Municipality of Lingayen with Current Account No. 0038-011369-002, maintained at the Philippine Veteran's Bank (PVB), Lingayen Branch, as the depository account for all cash donations to the Municipal Government of Lingayen, Pangasinan.


