### RESOLUTION NO. 299, S-2020

**REQUESTING THE HONORABLE WILLIAM D. DAR, SECRETARY, DEPARTMENT OF AGRICULTURE, TO ALLOCATE FUNDS IN THE AMOUNT OF ONE HUNDRED TWENTY-SIX MILLION PESOS (P126,000,000.00) FOR THE CONCRETING OF FARM TO MARKET ROADS IN VARIOUS BARANGAYS OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.**

WHEREAS, one of the main objectives of the current administration is to provide quality, consistent and efficient social services geared toward genuine progress with an active community;

WHEREAS, several agricultural barangays in Lingayen suffer difficulty in transporting their goods to the market because of poor quality of roads and high transportation cost; factors which contributed to the escalating prices of farm commodities in the local public market;

WHEREAS, to address this predicament, the municipality of Lingayen is focused on rehabilitating existing road facilities from the barangays to the town proper to cause the swift and efficient delivery of basic services to the people;

WHEREAS, the concreting of farm to market roads in various barangays of Lingayen will foster fast delivery of agricultural goods, products and supplies with cheaper transportation expense for the benefit of farmers/fisherfolks and the general public;

WHEREAS, the municipal coffer is suffering from the effects of the pandemic and in order to help alleviate the economic hardship of its constituents, the LGU is seeking help from well-meaning supporters to help in the realization of its economic visions;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request the Honorable William D. Dar, Secretary, Department of Agriculture, to allocate funds in the amount of One Hundred Twenty-Six Million Pesos (P126,000,000.00) for the concreting of farm to market roads in various barangays of the Municipality of Lingayen, Pangasinan.
