RESOLUTION NO. 302, S-2020

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO DONATE TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) TO THE PROVINCE OF CAGAYAN AND ANOTHER TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) TO THE PROVINCE OF ISABELA, AS FINANCIAL ASSISTANCE TO THE VICTIMS OF TYPHOON ULYSSES.

WHEREAS, Typhoon Ulysses struck the country on November 12, 2020 and wreaked havoc on many parts of Luzon including the provinces of Cagayan and Isabela;

WHEREAS, the typhoon brought huge volume of rainfall which triggered heavy flooding and landslides to said provinces bringing massive destruction to properties and a large number of casualties including deaths and missing persons;

WHEREAS, saddened by the unfortunate situation of the neighboring region, the Municipal Government of Lingayen decided to extend financial assistance with Bayanihan spirit in mind, to be channeled through the leadership of the League of Municipalities of the Philippines (LMP), Cagayan and Isabela Chapters, to help the victims of the massive flooding cope and survive the devastating effects of the calamity;

WHEREAS, the kind donation of the Local Government Unit of Lingayen will benefit many affected Cagayanos and Isabelanos who were displaced and injured by the worst disaster of 2020, thousands of whom lost their homes and properties, while others lost their dearly beloved loved ones;

WHEREAS, the fund for donation shall be drawn from the General Fund of the municipality, to be funded under Supplemental Budget No. 3, S-2020;

WHEREFORE, on motion of the House, duly seconded, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil, to donate Two Hundred Fifty Thousand Pesos (P250,000.00) to the Province of Cagayan, and another Two Hundred Fifty Thousand Pesos (P250,000.00) to the Province of Isabela as financial assistance to the victims of Typhoon Ulysses.


RESOLVED FURTHER, that copies of this resolution be furnished the Municipal Mayor, Municipal Budget Officer, Municipal Accountant and Municipal Treasurer, for their information and file.

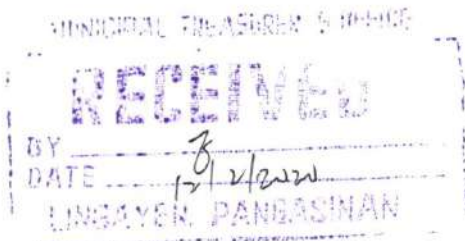
