RESOLUTION NO. 319, S-2020

AUTHORIZING THE HONORABLE MAYOR, LEOPOLDO N. BATAOIL, TO ALLOW THE ESTABLISHMENT OF A "BARATILLO" WITHIN THE VICINITY OF THE LINGAYEN CIVIC CENTER, THIS MUNICIPALITY.

WHEREAS, the Sangguniang Bayan received a letter from the Municipal Mayor requesting for a legislative measure allowing the establishment of a "Baratillo" within the vicinity of the Lingayen Civic Center;

WHEREAS, attached to the Mayor's letter is a letter request from small business owners who are desirous to set-up a "baratillo" in connection to the upcoming fiesta;

WHEREAS, the Municipal Government of Lingayen has suspended the holding of the 2021 Annual Capital Festival in compliance to the directive of the Inter-Agency Task Force for the Management of Emerging Infections Diseases (IATF-EID) which prevents activities that gather large number of people;

WHEREAS, in its desire to help the affected businessmen/women in the municipality, the Honorable Council gave a serious thought to the proposal, weighed the pros and cons, considered the risks and benefits, and has come up to a decision to acquiesce to the said request with the intention of providing new business opportunities to small business owners to help them recoup, begin anew, and earn money for the coming holidays and beyond;

WHEREAS, the flea market will be exclusive for Lingayen residents only and shall operate for the duration of three (3) months effective December 21, 2020;

WHEREAS, the presence of a "Baratillo" at the Lingayen Plaza will liven up the mood for the holidays and fiesta, and spur economic activity in the capital town which has been dampened by the ongoing pandemic;

WHEREAS, to assure the safety and well-being of the "baratillo" goers, PNP personnel will be assigned to patrol the area and see to it that health and safety protocols are observed at all times by both the vendors and customers alike;

WHEREFORE, on motion of the House, duly seconded, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Honorable Mayor, Leopoldo N. Bataoil, to allow the establishment of a "Baratillo" within the vicinity of the Lingayen Civic Center, this municipality.

RESOLVED FURTHER, that a copy of this resolution be furnished to the Office of the Municipal Mayor for his information and guidance.
