THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on December 14, 2020, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 325, S-2020

DECLARING BARANGAY ORDINANCE NO. 1, S-2020 OF THE SANGGUNIANG BARANGAY OF ESTANZA, LINGAYEN, PANGASINAN, ENTITLED, "AN ORDINANCE BANNING THE USE AND OPERATION OF VIDEOKE AND KARAOKE MACHINE AND OTHER SIMILAR AMPLIFIED SOUND DEVICES FROM MONDAY TO FRIDAY AT 8:00 O'CLOCK IN THE MORNING UP TO 5:00 O'CLOCK IN THE AFTERNOON IN BARANGAY ESTANZA, LINGAYEN, PANGASINAN PROVIDING PENALTIES FOR VIOLATION AND FOR OTHER PURPOSES.

WHEREAS, the Sangguniang Barangay of Estanza, Lingayen, Pangasinan, submitted its Barangay Ordinance No. 1, S-2020 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (A) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Rules, Regulations, & Privileges, Laws and Human Rights of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Barangay Council of Estanza shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Barangay Ordinance No. 1, S-2020 of the Sangguniang Barangay of Estanza, Lingayen, Pangasinan, entitled "An ordinance banning the use and operation of videoke and karaoke machine and other similar amplified sound devices from Monday to Friday at 8:00 o'clock in the morning up to 5:00 o'clock in the afternoon in Barangay Estanza, Lingayen, Pangasinan providing penalties for violation and for other purposes.
