RESOLUTION NO. 334, S-2021

ADOPTING THE INTERIM PREPARATORY GUIDELINES OF DILG MEMORANDUM NO. 2021-007 AND DILG DIRECTIVES ON VACCINATION PROCUREMENT AND ROLL-OUT BASED ON THE COVID-19 ROADMAP IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, the COVID-19 vaccination is considered both a breakthrough and a challenge particularly among developing countries like the Philippines;

WHEREAS, the National Government however, appreciates the initiative of Local Government Units to earmark funds for the purchase of COVID-19 vaccines for their constituents;

WHEREAS, the Department of the Interior and Local Government (DILG) in its desire to have a smooth implementation of the Vaccination Program in different localities issued Memorandum Circular No. 2021-007 on January 18, 2021;

WHEREAS, the Memorandum Circular embodies the Interim Preparatory Guidelines in the Implementation of the National Vaccination Program;

WHEREAS, in addition to MC No. 2021-007, the DILG through Secretary Eduardo M. Año has issued directives based on the COVID-19 roadmap relative to the procurement and roll-out of the said program;

WHEREAS, these directives include among others the coordination of the LGU with the National Task Force (NTF) against COVID-19 and the Department of Health (DOH) before vaccination procurement; reinforcement of the Incident Command Structure, and the constitution of a Technical Working Group to guide the localized implementation plan;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to adopt the Interim Preparatory Guidelines of DILG Memorandum Circular No. 2021-007 and the DILG directives on -vaccination procurement and roll-out based on the COVID-19 roadmap in the Municipality of Lingayen, Pangasinan.

RESOLVED FURTHER, that copies of this resolution be furnished to the Municipal Mayor, the Municipal Health Officer, the Chief of Police and BFP, for their information and guidance.
