THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on February 8, 2021 Via Zoom, the following resolution was approved.

RESOLUTION NO. 346, S-2021

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2021 OF BARANGAY LIBSONG EAST, LINGAYEN, PANGASINAN OPERATIVE.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Lingayen, Pangasinan as a legislative body is empowered to review ordinances authorizing annual or supplemental appropriations of barangays in the manner prescribed by law;

WHEREAS, the Sangguniang Barangay of Libsong East, Lingayen, Pangasinan submitted its Annual Budget for Calendar Year 2021 which was approved on December 17, 2020 through Appropriation Ordinance No. 01, S-2020;

WHEREAS, the Committee on Appropriation & Finance of the Sangguniang Bayan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, conducted preliminary review and study on said budget and hereby recommends to declare it OPERATIVE effective as of the date fixed in the Appropriation Ordinance with the following observations/recommendations:

1. That the utilization of appropriations from the 20% Development Fund shall be in accordance with the provisions of DBM-DILG Joint Memorandum Circular No. 2017-1 dated February 22, 2017 specifically Item 3.0 thereof;
2. That the disbursement of appropriations for development projects shall be in accordance with the approved Annual Investment Plan of the barangay;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 or the Government Procurement Reform Act; and
4. In the appropriation release, planning and budgeting process for the SK funds, the Barangay and SK Councils are enjoined to observe the policies and procedures prescribed under DBM-DILG National Youth Commission JMC No. 1 dated January 23, 2019.

WHEREAS, the Sangguniang Bayan after final evaluation, finds the same in order;



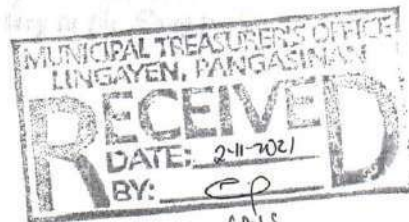
