RESOLUTION NO. 348, S-2021

CONFIRMING THE APPOINTMENT OF ENGR. JOHN SILVESTER A. TAPIA AS MUNICIPAL ENGINEER (MGDH) OF THE MUNICIPAL GOVERNMENT OF LINGAYEN, PANGASINAN.

WHEREAS, the appointment of Engr. John Silvester A. Tapia as Municipal Planning and Development Coordinator was forwarded to the Sangguniang Bayan for confirmation on February 4, 2021;

WHEREAS, the vacant position of Municipal Engineer (MGDH) is a mandatory position prescribed under Article VII, Section 477 of the Republic Act 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Section 443 (d) of the same Code provides that unless otherwise provided, heads of departments and offices shall be appointed by the Municipal Mayor with the concurrence of the majority of all the Sangguniang Bayan Members, subject to Civil Service law, rules, and regulations;

WHEREAS, the appointee has been screened and found qualified by the majority of the Human Resource Merit Promotion and Selection Board (HRMPSB) during a deliberation held on January 26, 2021;

WHEREAS, the filling up of the vacant position of Municipal Engineer is necessary in support to the Local Chief Executive's mandate of carrying out the delivery of basic and adequate services as provided for under Section 17 of the Local Government Code;

WHEREAS, the Municipal Engineer shall initiate, review, and recommend changes and policies in objectives, plans, programs, techniques, procedures and practices in infrastructure development and public works in general of the Local Government Unit of Lingayen to support the initiatives of the municipal leadership to achieve an improved quality of life for its people;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by all, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to confirm the appointment of Engr. John Silvester A. Tapia as Municipal Engineer (MGDH) of the Municipal Government of Lingayen, Pangasinan.
