**RESOLUTION NO. 349, S-2021**

**CONFIRMING THE APPOINTMENT OF MR. LARRY B. FLORES AS MUNICIPAL GENERAL SERVICES OFFICER (MGDH) OF THE MUNICIPAL GOVERNMENT OF LINGAYEN, PANGASINAN.**

WHEREAS, the appointment Mr. Larry B. Flores as General Services Officer (MGDH) was submitted to the Sangguniang Bayan for confirmation on February 4, 2021;

WHEREAS, pursuant to Section 443 (d) of Republic Act No. 7160, also known as the Local Government Code of 1991, department heads shall be appointed by the Local Chief Executive with the concurrence of the majority of all the Sangguniang Bayan Members, subject to Civil Service law, rules, and regulations;

WHEREAS, Mr. Larry B. Flores has been performing the duties and functions of General Services Officer since September 2019 as Officer-in-Charge and has since proven his efficiency and efficacy in delivering responsible and quality general services to the Municipal Government of Lingayen;

WHEREAS, the appointee has been screened and found qualified by the majority of the Human Resource Merit Promotion and Selection Board (HRMPSB) during a deliberation held on January 26, 2021;

WHEREAS, after careful study and evaluation of his qualifications and records, it was ascertained by the Council that Mr. Flores is very much qualified to the position and his appointment as General Services Officer is meritorious and advantageous to the municipality;

WHEREAS, as General Services Officer, he shall formulate measures for the consideration of the Sanggunian and provide technical assistance and support to the Mayor as the case maybe, in carrying out measures to ensure the delivery of basic services and provision of adequate facilities pursuant to Section 17 of the Local Government Code which require general services expertise and technical support services; Develop plans and strategies relative to general services to support the initiatives of the municipal leadership to achieve an improved quality of life for its people;
