RESOLUTION NO. 356, S-2021

EXPRESSING SUPPORT TO THE INITIATIVE OF THE PROVINCIAL GOVERNMENT OF PANGASINAN TO ESTABLISH A DIALYSIS CENTER AT THE LINGAYEN DISTRICT HOSPITAL, THIS MUNICIPALITY.

WHEREAS, the Provincial Government of Pangasinan intends to establish a Dialysis Center at the Lingayen District Hospital;

WHEREAS, by virtue of Provincial Resolution No. 2128-2021, approved by the Provincial Board in its regular session, the Province is seeking permission from the Department of Health to establish the said Dialysis Center to be housed in the compound of the Lingayen District Hospital;

WHEREAS, when approved, the same will be the second government-run dialysis facility in the province. The first facility named Mayor Julian V. Resuello Dialysis Center is located within the premises of the Pangasinan Provincial Hospital in San Carlos City, Pangasinan;

WHEREAS, a dialysis clinic will be beneficial especially to the people of Lingayen and the western towns of Pangasinan who need not travel to San Carlos City for their dialysis sessions which cost as much as P4,000.00, excluding the cost of laboratory examinations;

WHEREAS, in government-run dialysis clinics, the sessions are free, thus, easing the financial burden among the patients and their families;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem, duly seconded by all, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to express support to the initiative of the Provincial Government of Pangasinan to establish a Dialysis Center at the Lingayen District Hospital, this municipality.

RESOLVED FURTHER, that copies of this resolution be furnished to the Honorable Governor Amado I Espino, III and the Members of the Sangguniang Panlalawigan for their information and reference.
