**RESOLUTION NO. 370, S-2021**

**REQUESTING HON. EDUARDO “Bro. EDDIE” C. VILLANUEVA, REPRESENTATIVE, CIBAC PARTY LIST, TO ALLOCATE FIVE MILLION PESOS (Php5,000,000.00) IN HIS LOCAL INFRASTRUCTURE PROJECT (LIP) FOR FY 2022 FOR THE CONSTRUCTION OF A MULTI-PURPOSE BUILDING WITH PAVEMENT AT BARANGAY PANGAPISAN NORTH, LINGAYEN, PANGASINAN.**

WHEREAS, in pursuance to Section 12 of Republic Act 7160, otherwise known as the Local Government Code of 1991 which states that provinces, cities and municipalities shall endeavor to establish a government center where offices of national government shall be located, the Municipal Government of Lingayen is presently developing its own Government Center in a 10-hectare land located at Barangay Pangapisan North, Lingayen, Pangasinan;

WHEREAS, several national agencies have already signified their intention to construct and establish their satellite or field offices in the Government Center which will serve as a substitute administrative hub to ensure continuity of services;

WHEREAS, one of the main features of the Government Center is the construction of a Multi-Purpose Building with pavement which will serve as venue for various occasions, events and purposes;

WHEREAS, said Multi-Purpose Building will be part of the Lingayen Eco-Tourism, Forest Park and Camp Site which is projected to be a tourist destination where locals and tourists alike can experience and enjoy the natural beauty and charm of nature and the allure of Limahong Channel and the Lingayen Gulf;

WHEREAS, the Municipal Government do not have the needed financial resource to undertake the project hence the need to source out funds from other agencies;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Hon. Eduardo "Bro. Eddie" Villanueva, Representative, CIBAC Party List, to allocate Five Million Pesos (Php5,000,000.00) in his Local Infrastructure Project (LIP) for FY 2022, for the construction of a Multi-Purpose Building with pavement at Barangay Pangapisan North, Lingayen, Pangasinan.
