**RESOLUTION NO. 381, S-2021**

**REQUESTING SECRETARY WENDEL E. AVISADO OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR FUNDING IN THE AMOUNT OF TEN MILLION PESOS (Php10,000,000.00) FOR THE CONCRETING OF DON JULIO MAMAAT ROAD, BARANGAY CAPANDANAN, LINGAYEN, PANGASINAN.**

WHEREAS, one of the flagship programs of the Local Government Unit of Lingayen is the efficient delivery of basic services through continuous road improvements and networking;

WHEREAS, on January 8, 2021, the Department of Budget and Management (DBM) issued Local Budget Circular No. 131 granting financial assistance to qualified Local Government Units (LGUs) in need of funds for their development programs in their jurisdiction;

WHEREAS, Don Julio Mamaat Road in Barangay Capandanan, Lingayen remains unpaved and is classified as rough and gravel road;

WHEREAS, once concreted, it will ease the problem of the residents of the said area who are having a hard time traversing the road which generates lots of dust during dry season and becomes muddy throughout the wet season;

WHEREAS, the development of Don Julio Mamaat Road by concreting will benefit not only domestic tourism stakeholders but more so, the farmers and fisher folks from the area who would be given better access to market their local produce, thus effectively promoting both the tourism industry and the agriculture sector;

WHEREAS, the above-mentioned priority project is part of the duly approved Local Development Investment Program and Annual Investment Program of the LGU;

WHEREAS, the municipality lacks the financial capability to implement the afore-mentioned concreting project; As a consequence, there is a need to request the good Secretary of DBM for the much-needed funding;

WHEREFORE, on motion of SBM Jasper S. Pasion, duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Secretary Wendel E. Avisado of the Department of Budget and Management (DBM) for funding in the amount of Ten Million Pesos (Php10,000,000.00) for the concreting of Don Julio Mamaat Road, Barangay Capandanan, Lingayen, Pangasinan.
